ARTICLE I

NAME

The name of this corporation shall be South Jersey Girls Softball Association, hereinafter referred to as the "Association".

ARTICLE II

OBJECTIVES

The objective and purpose of the Association is to provide organized and supervised competitive softball games for member towns and organizations, while still maintaining sportsmanship, character and the spirit of team effort.

ARTICLE III

ELIGIBILITY TO MEMBERSHIP

<u>Section 1.</u> The membership of the Association is open to all towns and organizations within the Southern New Jersey area who provide a valid medical insurance coverage certificate. All applications for membership must be in by the February meeting and approved by the Association Board of Trustees, hereinafter referred to as the "Board". Teams, organizations or individuals who have not demonstrated the proper ethics, concerns for development and commitment to the Objectives of the Association will be denied membership.

<u>Section 2.</u> Each team becomes one (1) member in the association. The team manager or authorized representative (either by written statement or call to the Board) becomes the official team's representative to the Association and is entitled to all of its privileges as stated in Article IV.

<u>Section 3.</u> Any town or organization that is not included in the above section and is willing to put forth the effort and cooperation for the betterment of the Association, may be considered for membership upon approval of the general voting membership present.

Section 4. All member town's or organization's games must be played within a forty (40) mile drive from an opposing member town or organization, the game(s) may be played on a weekend and/or a neutral site a common distance from both teams. Any exceptions must be approved by the Board.

<u>Section 5.</u> An "honorary membership" will be given to anyone (minimum age 18) who is willing to put forth the effort and cooperation for the betterment of the Association. An "honorary member" can attain privileges as stated in Article IV, however, they cannot attain voting privileges until after one (1) full year as a member in good standing. Honorary Memberships are only open to people that been listed on an official Association roster.

<u>Section 6.</u> Any member or affiliate of the Association may be subject to suspension and/or removal upon written charges brought before the members of the board at a set hearing date. A two-thirds majority of the Board will constitute action. Appeals may be made as per Article XV.

ARTICLE IV

MEMBER IN GOOD STANDING

<u>Section 1.</u> A member in good standing of this Association is an eligible member who attends not less than five (5) regular meetings in the previous (or current) year (January 1 to August 31). In addition, each member must not have any outstanding debt with the Association.

<u>Section 2.</u> A member in good standing must pay their membership fees (teams) or dues (honorary membership) by March 31 of the current season.

<u>Section 3.</u> A member in good standing of this Association is entitled to the following rights and privileges:

a) Voting in Association officer elections. b) Voting in all official Association business. c) Voting on Rules and Regulations d) Eligibility to hold office within the Association, e) any benefits given to and by the Association.

<u>Section 4.</u> Any member in good standing who misses more than three (3) consecutive meetings will lose all privileges. Reinstatement is described in Article IV Sections I and 2.

<u>Section 5.</u> At no time should any member, officer, Commissioner or any other person affiliated with the association interfere with a game in progress. Any problems or discussions must be handled after the completion of the game.

Section 6. Should a team's authorized representative (Manager) be no longer affiliated with the team, town or organization and has attended the proper number of meetings, and has attained all other member in good standing status, said membership may be transferred to an Honorary Membership without loss of privileges, provided payment of dues.

ARTICLE V

OFFICERS AND BOARD OF TRUSTEES

<u>Section 1.</u> The elected officers of the Association are Chairperson, Vice-Chairperson, Treasurer, Secretary and three (3) Trustees and Chief Commissioner. The terms for all officers are for one (1) year or until replaced.

Section la. No member can hold more than one (1) elected office at one time.

<u>Section 1b.</u> There may be more than one (1) elected officer from each participating town or organization.

<u>Section 2.</u> Nominations for officers will be held at the regular meeting for the month of July. Floor nominations and elections for said officers will be held at the regular meeting for the month of August (reorganization). Election will be by secret ballot.

Section 3. The elected officers will serve as the Board for the Association.

<u>Section 4.</u> The Chairperson, with the approval of the Board, may appoint such other officers as shall be deemed necessary, who shall have such authority and shall perform such duties as from time to time may be prescribed by the Chairperson and the Board.

<u>Section 5.</u> The Chairperson shall be able to spend up to \$100.00 without prior approval of the Board. All other expenditures shall be approved by the Board.

<u>Section 6.</u> Any other officer of the Association may be subject to removal upon written charges brought before the other members of the Board at a set hearing. A vote of two-thirds of the general voting members present are necessary for removal from office. Appeals may be made as per Article XV.

ARTICLE VI

DUTIES OF OFFICERS

<u>Section 1.</u> The Chairperson shall when present, preside at all official meetings, and have the power to call special meetings when deemed necessary. The Chairperson shall make and sign contracts and agreements in the name and on behalf of the Association with the approval of the Board. The Chairperson shall have the general management and control of the business affairs of the Association and shall generally do and perform all acts incident to the office of Chairperson, or which are authorized or required by law.

<u>Section 2.</u> The Vice-Chairperson shall be vested with all the powers and shall perform all the duties of the Chairperson in the absence or disability of the latter, or until the Board shall otherwise determine. The Vice-Chairperson will sit as a member of the Board and perform such other duties as shall be described by the Board.

<u>Section 3.</u> The Treasurer shall have custody of all funds, securities and receipts of the Association and shall give cause to be given receipts and acquittance for moneys paid in and on account of the Association and shall pay out of the funds on all just debts. All amounts to be paid must be authorized by the Chairperson. The Treasurer shall keep all records of moneys received or paid out and submit a verbal report each regular meeting and a written report at the end of each Association year.

<u>Section 4.</u> The Secretary shall give notice of all meetings as required and sit as a member of the Board. The Secretary will be responsible for the recording of the proceedings of all meetings and the maintenance of these recordings, and shall handle any correspondence, either incoming or outgoing, as directed by the Chairperson and perform any other duties as prescribed by law and the Board.

<u>Section 5.</u> The three (3) Trustees will sit as member of the Board and perform such duties as prescribed by the Board.

Section 6. The Chief Commissioner shall coordinate all activities between the Association and contracted umpire associations. This includes not only the submittal of finalized season game schedules to the umpire associations and notification of any changes to those schedules but also resolution of game/manager/player problems with the umpire associations, The Chief Commissioner shall resolve problems that may arise between teams in the Association with Board input, if necessary. This includes chairing the Ad Hoc Protest Committee and unresolved game schedules.

ARTICLE VII

MEETINGS, FISCAL YEAR

<u>Section 1.</u> The regular Association meetings are to be held monthly on a date and a place as approved at the reorganization meeting.

<u>Section 2.</u> The presence of not less than five (5) members in good standing will constitute a quorum and shall be necessary to conduct business and hold elections of this organization. A majority of voting members present shall decide all matters of business.

Section 3. The year for the Association will begin on January 1 and end on August 31.

ARTICLE VIII

COMMISSIONERS

<u>Section 1.</u> The Chairperson shall appoint a Commissioner for each division at every age level. A Commissioner may not be affiliated with any team in their division.

Section 2. The duties of a Commissioner shall be:
A) Scheduling and rescheduling of games.

- B)Receiving of problems and consulting with the Chairperson of the Commissioners' Committee to resolve the problem.
- C)Coordination of umpires.
- D) Receiving of protest and presenting it to Board and Umpire Association.
- E) Maintaining current standings and reporting standings on a weekly basis.
- F) Maintenance and certification of rosters.
- G) Responsible for establishing firm play-off schedules for all semifinals and finals play-off games with the four teams involved.

<u>Section 3.</u> In the absence or unavailability of a Commissioner, a Coordinator shall have the authority to perform all duties of the Commissioner. The Coordinator performing these duties shall report all actions to the Chief Commissioner in a timely manner.

ARTICLE IX -

MANAGERS. COACHES AND PLAYERS

Section 1. All managers must be age 21 or older and all coaches must be 18 or older

<u>Section 2.</u> Each team may roster only one (1) manager, a maximum of three (3) coaches, a scorekeeper, a team parent and a bat person.

Section 3. Only rostered team officials are permitted on the field and in the team bench area.

<u>Section 4.</u> All managers and coaches must maintain proper control and supervision of their teams (and fans) at all times.

<u>Section 5</u>. Any coach or manager, who by his/her conduct or failure to abide by the rules and regulations and/or By-Laws, subjects himself/herself to game suspensions pending written charges to be brought before the board. Upon reviewing with the Board, a hearing date will be set and a decision rendered by the Board. Any appeals shall be made to the Board of Appeals.

Section 6. Recruiting of players from any other established team in the Association is prohibited. Anyone found guilty (after a hearing) will be suspended from the Association. The Chairperson will send a letter to the town or organization regarding the problem.

<u>Section 7.</u> Any player who willing desires to change teams must first petition the Board for approval on the required form before April 1 or after June 15 (no team transfers between April 1 and June 15). The player must show legitimate reason for change; a release must be obtained from the current team or organization. If no release can be obtained, the Board will investigate and render a decision. The Board shall review all requests and approve or deny roster move. If denied, the player cannot be certified on roster.

<u>Section 8.</u> Under no circumstances shall there be any alcoholic beverages or unauthorized drugs at the game or on the field. Smoking is not permitted while coaching a base or in the dugout.

<u>Section 9.</u> All rosters and completed team evaluations are due by the designated March meeting. Teams' rosters turned in at the March meeting must have a minimum of eleven (11) players including all excepted players (<u>One (1) excepted player for every two (2) regular players for a maximum of five (5) excepted players.</u> Team evaluations will be accomplished immediately following the meeting. Rosters will be finalized at the designated April meeting. If at any time during the season a team's roster falls below thirteen (13), regular players may be added and these players added must play in at least five (5) regular season games to be eligible for a play-off roster

Section 10. In the interest of a clean game with no bad feelings between teams, players and coaches are only permitted to cheer for their own team and not against an opposing team. Intentional derogatory remarks or abusive language will not be tolerated and the guilty party will be subject to ejection and/or suspension.

Section 11. Any manager or coach ejected from a game may be fined \$100.00, under review of the board, and may be suspended for a MINIMUM of one (1) game. The ejected individual will pay the fine from his or her own personal funds after the board deems necessary. The team will not be subject to the payment of the fine. Further, the ejected individual will not be allowed to attend any of his or her team's games until the fine is paid to SJGSA. Any player ejected from a game will be suspended for a MINIMUM of one (1) game. The opposing coach will report the incident of the ejection of the manager, coach or player to the League Commissioner within twenty-four (24) hours or they may be suspended for a minimum of one (1) game. The League Commissioner will notify the Team Manager of the suspension of the ejected individual before the next scheduled game. If the cause of the ejection is considered extremely serious by the League Commissioner, additional suspensions or further actions may be taken by the League Commissioner. If further games are involved, the player must be in uniform and in attendance at the next game and verified by the opposing coach that she is present. If the player is not present, she will have to remain out until she is present for the game or games suspended. A suspended manager or coach must not be within sight or sound of the ball game.

Section 12. In the event of fighting between players, both or all parties will be suspended for a minimum of one (1) game and will be subjected to whatever additional penalty deemed necessary by the Board.

Section 13. There is no minimum playing time for players.

<u>Section 14.</u> Any team found using an ineligible player will forfeit the game and be subject to any fines or penalties as determined by the Board.

<u>Section 15.</u> At any time, an injured player (with a Doctor's approval) may be taken off the roster and a replacement player may be added, provided the roster is below thirteen (13) players. The injured player must remain off the roster for a minimum of ten (10) days following her replacement. If she is reinstated after that time (with a Doctor's authorization), the replacement player must be removed from the roster. If the replacement player remains on the roster, due to the roster falling below 13 players or the injured player not returning, she must have played in (four (4) for ten (10) game schedules and five (5) for a twelve (12)game schedule) to be eligible for the play-offs.

Section 16. Rostered players must play in 5 games to be eligible for the playoffs in a season with 12 or more games scheduled. Exceptions may be considered if any originally rostered player becomes injured and cannot play the entire season. Injured players will need a physician's letter stating the date the player was withheld from playing and the date when she may return to play. It is the coach and player's responsibility to get the necessary letters from the physician and immediately present a letter to inform the respective league commissioner that said player will be withheld from playing, player cannot return to play until a letter releasing her from a Physician's care is presented to their respective league commissioner. Any injured player that does not play the required 5 games will have to play in at least 50% of the games that she was eligible to participate during the season. If an injured player is permanently replaced on a team's roster, the same guidelines will apply. A letter from a Physician must still be presented to their respective league commissioner stating the date of the injury and replacement player must still be approved under SJGSA guidelines.

Section 17. The Board must approve all managers and rostered teams from each franchise. Once a manager and team is finalized by each town or organization and approved by the Board at the beginning of the season, the Manager and roster become under the jurisdiction of the Association. Should any town or organization desire to make any changes, the Association must be notified in advance and take whatever action deemed necessary in order to uphold the dignity of and decide what will be in the best interests of the Association.

Section 18. A rostered team official must remain in the dugout section of the field at all times.

<u>Section 19.</u> Rostered players must be from the designated Association or area with the "Exception of one (1) player per every two (2) regular players as defined below". Players noted as <u>Regular or Excepted.</u> For interpretation, note the Following categories (use in declining order):

A) Organizations

- (1) Regular Players a) Declared "Free Agent" (as applied to and approved by the Board for: (i) New, moved into town (ii) Has not played Association ball for one (1) season and resides in normal drawing area as determined by the Board.
- (2) Excepted Players (limited to one (1) for every two (2) regular, examples six/seven (6/7) regular players is a maximum of three (3) and eight/nine (8/9) regular players is a maximum of four (4) and ten (10) or more is a maximum of five (5) excepted players) Excepted players remain excepted players for three (3) years. If an excepted player is from a town without a team in the division they are playing and that organization forms a team the following year, the player will have the choice of remaining with the current team or returning to their home team. Once this decision is made, it is permanent and the player cannot switch teams in the future (at any level) unless her hometown once again does not have a team at her level.

- B) Special Considerations (for one (1) season only)
 - 1) Applications made to the Board for any other situations not noted above. a) Hearing made by general membership, b) Vote by Board
 - 2) Organizations that merge for a team (when neither has enough to fill a minimum team roster (11).
 - 3) A maximum of three (3) excepted players will be allowed on a Consideration Team.

Section 20. Guidelines for adding and deleting players to GSA roster.

- A). Players dropped from a roster are not permitted to play for that team again for the remainder of the season. This does not include players who fall within the injury guidelines of Article IX Section 15.
- B). Managers submitting players to be added to an approved roster must submit an evaluation form for that player to the Commissioner of that division before said player may PARTICIPATE in ANY GAMES. Commissioner will decide on eligibility of that player for the division being applied.

Commissioner will notify that team if the player is accepted or denied. If the Player is accepted, then the Commissioner will notify all ether teams in that division. (This does not apply to "Call-up" players from in-town or to the Senior I, Jr. Olympic Division or Major I teams).

- C). Any team using any player not approved for play at that level, will receive a forfeit for all games in which that player participates and will be fined accordingly.
- D). Teams must follow all other guidelines of Article IX, Section 15.

ARTICLE X

FEES AND DUES

<u>Section 1.</u> Association fees will be established at the February meeting, as soon as an approximate number of participating teams can be determined. Each team must submit their fees by March 31.

<u>Section 2.</u> Each team will be required to post a \$100.00 performance bond in addition to the entrance fee. Bonds shall be held in the Treasury, and upon request will be refunded at the end of each season, providing no fines were levied. If fines cause the bond to go to zero or below, it must be replenished to continue the season.

Section 3. "Honorary membership" dues will be \$5.00 payable by March 31.

<u>Section 4</u>. Any umpire fees will be split by both teams. In the event there is a forfeit, the forfeiting team will be responsible for the full cost of the umpire. If the forfeiting team is not present, the present team will pay the cost of the umpire and will be reimbursed from the forfeiting team's bond. This only applies to games that are forfeited on the field.

ARTICLE XI

PENALTIES AND FINES

<u>Section 1.</u> Teams will be assessed fines based on the following. Amounts are to be deducted from the bond posted at the beginning of the season.

- A) A manager or rostered coach must be present from each team for the Feb, March and the two April meetings or else fined \$25.00 per violation (unless they have a game).
- B) Failure to report scores within 24 Hours. (\$5.00)
- C) Incomplete Roster (\$10.00)
- D) Approved game rescheduling (1st request). (\$10.00)
- E) Approved game rescheduling (2nd request). (\$20.00)
- F) Requests for third game rescheduling will not be accepted.
- G) A team may request (with the approval of the Commissioner) on an emergency game "deferment" for extenuating school-related circumstances <u>after using its two (2) allowable game changes.</u> The game will be "deferred" meaning it must be played within the prescribed period of time by the Commissioner (no longer than five (5) days). There is no fine for deferment.
- H) Game changes for High School Tournament games are classified as "deferments" with no fine or penalty, but must be replayed as soon as possible as prescribed by the Commissioner.
- I) All games must be rescheduled within seventy-two (72) hours of cancellation and replayed within fourteen (14) days of same, or otherwise approved by the Commissioner. The Commissioner must reschedule the game if not done by the teams within seventy-two (72) hours. Teams with an impasse on dates must immediately contact the Commissioner for resolution. If a game is not rescheduled within seventy-two (72) hours, one or both teams will be fined \$25.00. If not rescheduled within seven (7) days, one or both teams will receive a forfeit.
- J) No make-up games will be permitted during the last week of the regular divisional season except for inclement weather that has caused the cancellation of games after Memorial Day weekend.

- K) Should a Coach or Organization fail to properly declare a player status on the S.J.G.S.A. Evaluation Form, including affiliations with any outside "tournament/ASA etc." teams and school teams, as determined by an appointed committee, shall possibly incur penalties and/or fines from \$25.00 up to forfeiture of the team bond and possibly the forfeiture of the Organization's total bond, depending on the severity as found by the committee.
- L) Any violations of said By-Laws or Rules and Regulations. (\$10.00)

Section 2. Any outstanding team debts will be deducted from their bond.

<u>Section 3.</u> Teams that forfeit will be fined \$25.00 for first offense; \$50.00 for second offense; Third offense will result in suspension of season and forfeiture of remaining bond, as well as Probation (allowance for only one (1) forfeit) for next season.

ARTICLE XII

AGE LEVELS

The Association shall establish the following Age Levels: 16 to 18 (with 15 permitted); 13 to 15 (with 12 permitted); 11 to 12 (with 10 permitted); 9 to 10 (with 8 permitted). Teams shall make application to participate in one of the Age Levels. A <u>Team Evaluation Committee</u> shall be appointed by the Chairperson for each Age Level, which shall place teams in the prospective Divisions based upon competitiveness, and in conjunction with team applications and team evaluation forms. Any appeals of Committee decisions must be made to the Board within 24 hours of notification of Division placement.

Any player not covered under the proceeding guidelines will be evaluated case by case. The player in question will be evaluated and after SJGSA board approval and written consent from players parents or guardian, will be placed in the appropriate division of play for the current year.

Section 1. The Senior Level ages will be 16 to 18. Players age 15 are permitted to be rostered on a Senior Team. Players rostered on two (2) teams must play for the team in which their age falls unless their manager agrees she may play for the older team on conflicting nights. Senior Level teams can only double-roster from their "top" junior team. Players who are 14 and are varsity level players will be considered to play at the senior level but a written request must be given to their respective Commissioner and player must receive approval. If a player is 14 but has not yet reached High School, they may play with a written request to their Commissioner and said player is evaluated and approved. Under no circumstances will any player below the age of 14 be permitted to play at the senior level.

Section 2. The Junior Level ages will be 13 to 15. Players age 12 are permitted to be rostered on a Junior Division team and also rostered on a Major team. Major players age 12 rostered on two (2) teams must play for the team in which their age falls unless their manager agrees that they may play for the older team on conflicting nights.

A) The Junior Level shall consist of the Olympic, National, American and if necessary, Patriot Divisions. The Olympic Team shall be considered most competitive, National and American Teams competitive and Patriot Teams mildly competitive. The Evaluation Committee will place teams in these Divisions by a review of the team evaluation form. Towns submitting more than one (1) team in the Age Level should set up teams based on strength.

Section 3. After the first week of the season, a lower Division player may be added to an upper Division roster (same organization) for a maximum of three (3) games, regular season only. Should injury occur on upper Division team - see ARTICLE IX Section 15, three (3) game maximum does not apply for injury replacement. At no time can a player be officially rostered on two (2) Division teams. All roster moves must be approved by the Division Commissioner prior to a game.

<u>Section 4.</u> The Major Level ages will be 11 and 12. Players age 10 are permitted to be rostered. Players age 9 are permitted to be rostered only with the League's Commissioner's approval.

Section 5. The Minor Level ages will be 9 and 10. Players age 8 are permitted to be rostered only with the League Commissioners approval. Players age 10 are permitted to be rostered on a Major team and also rostered on a Minor team. Minor players age 10 rostered on two (2) teams must play for the team in which their age falls unless their manager agrees that they may play for the older team on conflicting nights. Under no circumstances will 9 year old players be permitted to play on a Major Level Team without the League's Commissioner's approval.

<u>Section 6.</u> Call-ups from within your organization (Regular Players Only) to an upper age level must be approved by your Commissioner.

Section 7. The official league age is the player's age on January 1.

<u>Section 8.</u> Player's birth dates must be certified each season, either by presenting birth certificate (copy) or copy of previous year's certified Association roster.

ARTICLE XIII

APPLICATIONS, TOURNAMENTS AND ALL-STARS

<u>Section 1.</u> Any affiliations with national or statewide organizations must be approved by the Board and the majority of the general voting membership.

Section 2. The Association shall hold no restrictions on post-season tournaments.

ARTICLE XIV

COMMITTEES

<u>Section 1.</u> Any Committees of the Association can be created and members appointed by the Board as shall deem necessary, who shall have such authority and perform such duties as from time to time as may be prescribed by the Board.

Section 2. Standing Committees shall be as follows:

- A) Applications/Rosters
- B) Team Evaluations/Division Schedules
- C) Commissioners
- D) Umpires/Rules/Grievances
- E) Finances/Fees/Bond/Fines
- F) Awards/Special Events/Communications

<u>Section 3.</u> Each participating town or organization will be responsible for providing an individual to work on the above named standing committees. This individual's volunteer effort will be in addition to his/her regular duties to the town or organization team and not in lieu of those regular duties. Towns or organizations with several participating teams may be required to provide more than one individual.

ARTICLE XV

PROTESTS AND BOARD OF APPEALS

<u>Section 1.</u> Any protest of a game must be in writing and turned into the Chief Commissioner within 48 (forty-eight) hours of the end of the game. A \$20.00 Association fee must accompany said protest (cash, not from bond). The Chief Commissioner will review the protest with the Ad Hoc Committee which will render their decision and recommendation to the Board for their action or further review with the Umpire Association if necessary. The protesting team must pay all fees (including any Umpire Association fee). Protests shall be denied in this procedure is not followed.

<u>Section 2.</u> A Board of Appeals will be appointed by the Chairperson for each case to be heard in the event of any appeals of Association decisions pertaining to the Rule and Regulations, fine or suspensions. Administration decisions (By-Laws) cannot be appealed.

<u>Section 3.</u> The Board of Appeals shall consist of three (3) members as available. Any potential conflicts of interest should not be part of this Board.

Section 4. The Board of Appeals shall render a written report and decision within seven (7) days of the hearing.

<u>Section 5.</u> The Ad Hoc Committee will be composed of the chief Commissioner and two (2) non-Board members in good standings of the S.J.G.S.A previously approved by the Board Chairperson.

ARTICLE XVI

AMENDMENTS

<u>Section 1.</u> Any member in good standing will be eligible to submit in writing, possible amendments to these By-Laws at a regular meeting, and voted upon at another meeting. Such amendments must be passed by a two-thirds majority of the general voting membership present. All By-Laws Amendments must be approved before the January regular meeting to be effective for the upcoming year.

AMENDMENT I

Section 1.

- A) There shall be no restrictions on the number of teams from one (1) organization that can be placed in any age level. Teams will be assigned as decided by the Evaluation Committee
- B) Players within an organization shall be permitted to move up Divisions after initial rosters are submitted for a maximum of three (3) games (after that they must return to the lower division team or remain with the upper division team, also see By-Laws Article IX Section 9). No player shall be allowed to play at a lower division team at any time once rostered on an upper division team. This shall apply to ALL AGE LEVELS.
- C) Each Division Championship Team shall receive a single trophy and team jacket allowance. Each Divisions Runner Up will receive a single team trophy. Play-offs will occur in all divisions. High School Seniors who are currently rostered on an Association team and have played a minimum of three (3) seasons in the Association will be considered for a financial award after college acceptance. The number of awards and their amounts will be determined by the Scholarship Committee.
- D) A player who has played four (4) for a ten (10) or five (5) for a twelve (12) regularly scheduled games) regular games in an upper level team but remains with her lower level team will be eligible to play in the play-offs for either team. This applies to any age level. Under no circumstances shall a player be permitted to play on more than two (2) play-off teams. If a player is eligible for more than two (2) play-off teams, she may play for any two (2), one (1) must be her regular season team.

Section 2. Play-offs

A) The top four (4) teams in each level shall participate in the divisional play-offs. Semifinals are first place vs. fourth place and second place vs. third place. In the event a team eligible for the play-offs cannot participate in the play-offs, the fifth place team in the division's final standings shall become eligible for the play-offs and shall adhere to the fourth place play-offs schedules. If the fifth place team cannot participate, the first place team receives a bye in the first round of the play-offs.

Playoff formats may be modified by the division commissioner (with board approval) based on extenuating circumstances.

B). Ties in the standings between two (2) teams shall be decided as follows: Head to Head; 2) If a split, runs against between the two (2) tied teams: 3) a one (1) game play-off held on a site determined by the Division Commissioner with a coin flip for home team. **Exception:** Ties between second and third place will be a coin flip. If there is a tie between more than two (2) teams, the cumulative best records between play of those teams will determine the top two (2) spots. Should there still be a tie; the next tiebreaker would be runs against between the teams. Should there still be a tie; the Division Commissioner shall draw team names to determine which teams play each other with a coin flip for home team.

<u>Section 3.</u> When a lower team (Senior II, Senior III, National, American, Patriot or Major II) falls below a roster of thirteen (13) players and picks up an additional player who is not already rostered in the league, the Commissioner will determine if the player is eligible to play at that level. If the player is determined to be a player that should be playing on a higher level team, she will not be permitted to be rostered with that team.

AMENDMENT 2

Guidelines for Independent Teams entering S.J.G.S.A,

Section 1). Teams must declare a "Home" territory.

- A). If team is based in a town that already has existing teams in S.J.G.S.A., they will only be able to roster players as described in Section 2.
- B). If team is not clearly based in a town, the Board will decide on their drawing area.
- C). If team is based in a town that has no teams in S.J.G.S.A., the Board will verify the normal drawing area of that town, that will become their drawing area. If that town registers with S.J.G.S.A, in future years, the independent team will then have to follow the guidelines in Section 2.

Section 2). Teams registering within an existing S.J.G.S.A. town.

- A). Players who have not played for the existing town in the previous year, will be considered regular players.
- B). Players who never played for the existing town will be considered regular players.
- C). Players who have been rostered and played for that team (in the previous year) can only be rostered by the independent team if a release is applied for and approved by S.J.G.S.A. These players will be considered as Excepted Players.

D). Players desiring to apply for team releases must follow the guidelines of Article IX, Section 7.

- <u>Section 3).</u> Players not rostered as regular players (EXCEPTED PLAYERS) will be limited to one (1) for every two (2) regular players., this will include any players released from the town within their drawing area and any players rostered outside of their normal drawing area, players outside of a team's normal drawing area are considered Excepted Players regardless if they are from an area that is affiliated with S.J.G.S.A. or does not have any teams in S.J.G.S.A.
 - A). Players who are considered Excepted, will remain Excepted for three (3) years, as described in Article IX, Section 18 of these bylaws. All other guidelines of Excepted Players in Article IX, Section 18 must be followed.

AMENDMENT 3

<u>Section 1).</u> Any team who is eligible for the league to reimburse umpire money, due to making the playoffs, must come to the first meeting following the conclusion of the playoffs to collect their reimbursement. Payment will not be credited to league fees or bond. If a representative from the team does not collect umpire money at this meeting, all umpire money will be forfeited to the scholarship fund.
